The CEO of KEA and chairperson of the Empanelment Committee for empanelment of Evaluation Consultants and Independent Assessors welcomed all the members of the committee to the meeting.

The Member-Secretary of the committee informed that the chairperson hadconstituted a team ofthree officers of KEA under order bearing no. KEA 109 EVN 2014, dated: 23-05-2014 as "Desk Appraisal Team". The team has done the

desk appraisal, and allotted scores to the seven applicant Consultant Evaluation Organizations who had applied for fresh empanelment in response to notification no. KEA 109 EVN 2014 (Volume-IV), dated: 06-04-2016 andM/S Council for Social Development, New Delhi, who had applied earlier. The last date for receiving the applications was notified as 07-05-2016.

The Desk Appraisal Team, it was informed, has gone by the contents ofparagraph 11 (2) of the manual and found that theapplicant Consultant Evaluation OrganizationM/S Pan India Network, 10-2-152, Bank Colony, Sangameshwara Nagar, Gulbarga, did not satisfy the "Essential Eligibility Criteria" number 11(2)(D) which required that for empanelmentConsultant Evaluation Organization should have carried out "at least five evaluation/research or consultancy studies over the past five years using its own research staff'. M/S Pan India Network has reported of having carried out five assignments on pages 40 and 41 of Annexure A of the empanelment documents. A copy of that is appended as Appendix 1. Of that, three assignments (The two forest ones and that at serial number 5) are seen to have been done by HKCAL - an empanelled Consultant Evaluation Organization of KEA. Hence, effectively the number of assignments done by M/S Pan India Network is THREE and not FIVE. Thus it fails to meet the essential standard detailed in paragraph number 11(2) (D) of the Empanelment Manual. Accordingly, it was were resolved that PAN India was not qualified ofbeing empanelled at this juncture.

The score sheet of the balance SIX(7-1=6)) applicant Evaluation ConsultantOrganizations was then considered. Along with that, and as a special case, the application of M/S Council for Social Development, Sangha Rachana, 53 Lodi Estate, New Delhi-110 003. They had applied earlier to the date of notification. The scoring had been done by the desk appraisal team and given to the

Chairperson of the Committee as prescribed inparagraph 17 of the Empanelment Manual. Copies of the detailed score sheet was given to all members of the the committee. The members agreed to the score in principle. Since the scores of each of them was above 100, it was resolved that all the SEVEN applicant Consultant Evaluation Organizations were eligible for empanelment for the period 2016-17 to 2018-19. One of the members vaguely recalled GRAMM being complained against in the matter of an evaluation study done by them probably for the Education department. The nature of the complaint too was not capable of being recalled by the member during the meeting. The Committee decided that the empanelment of GRAMM can be done subject to the discovery/confirmation of the complaint and its outcome. The Consultant Evaluation Organizations so empanelled (names occur in alphabetical order) and the sectors for which they are empanelled using the criteria evolved and resolved in the first meeting of the Empanelment Committee held on 14th July 2014and being followed since then are—

De-empanelment, the said paragraph itself provides, is within the authority and responsibility of the Empanelment Committee.

As per paragraph 39(i) of the Empanelment Manual, a Consultant Organisation or Independent Assessor can be de-empaneled if they "indulge in Plagiarism".

The CEO, KEA, informed the Committee as to how one instance of plagiarism had been detected in the draft evaluation report of the evaluation study of the performance of Karnataka State Coir Development Corporation. This study was allotted to Institute of Public Enterprise, Osmania University Campus, Hyderabad. He narrated the sequence of events of issuance of notice, receipt of reply, cancellation of the MoU for doing evaluation study etc. and place the related file no. KEA 36 EVN 2012 (P3) for the perusal of the Committee members. He said that the appeal of the Institute of Public Enterprises against the order of CEO, KEA, proving the charge of plagiarism and cancellation of MoU preferred with the Principal Secretary, Planning, Programme Monitoring and Statistics department has been dismissed. The order of the CEO and proving the charge of plagiarism is consequently upheld and is in operation.

With the charge of plagiarism thus standing proved, he recommended the Empanelment Committee to resolve to de-empanel the said Consultant Evaluation Organization.
