Annual Report of Karnataka Evaluation Authority for the year 2015-16

I. Introduction

Karnataka Evaluation Authority (KEA) was set up vide Government of Karnataka order no. PD/8/EVN (2)/2011 dated 11th July 2011and registered as a society vide registration number DRB-C/SOR/140/2011-12 on 19th September 2011 of the District Registrar of Cooperative Societies, Malleswaram, Bangalore-560003 under the Karnataka Societies Registration Act, 1960. It functions under the purview of Planning, Programme Monitoring and Statistics Department (PPMSD).

The main functions of KEA are to

- A. Lay down standards for the evaluation of programmes and policies of the state:
- B. Provide institutional machinery to facilitate, supervise and enforce timely, useful and accountable evaluations:
- C. Build capacities of public agencies and independent evaluation agencies to undertake effective evaluations:
- D. Ensure that the evaluation outputs are utilized for informal decision making and enhanced citizen satisfaction.

II. Activities of KEA during 2015-16

KEA initiated a number of activities during 2015-16. Its details are given below:

A. Regarding Personnel and Administration: KEA has one full time Chief Evaluation Officer on deputation from the Indian Forest Service, one Administrative Officer on deputation from the Karnataka Secretariat Service, Two Associate Directors on deputation from Directorate of Economics & Statistics, Planning Department, an Accounts Officer from KIPA, supporting staff on out sourcing basis and two retired Government employees as Consultants.

In 2015-16, KEA has published Compendium of Findings and Recommendations of the evaluation studies conducted by Karnataka Evaluation Authority (KEA) from 2011 to November 2015.

The Income Tax department granted exemption from income tax to KEA under section 12AA(a) of the Income Tax Act 1961 vide certificate number DIT (E) BLR/12AA/AACAK3058R/ITO(E)-1/2014-15/G-356 dated 16th June 2014.
