# APPROVED TERMS OF REFERENCE FOR THE EXTERNAL EVALUATION OF "SPECIAL SCHOOLS UNDER CHILD CENTRIC SCHEME" FOR DIFFERENTLY ABLED CHILDREN

#### 1. Title of the study:

Impact Assessment of the Scheme "Financial Assistance to Special Schools for Physically Challenged Run by Non Government Organizations (NGO) under Child Centric Scheme" of the department for Empowerment of differently-abled and Senior Citizens, Government of Karnataka.

#### 2. Department/Agency Implementing the Scheme/Programme:

The Department for the Empowerment of Differently-abled and Senior Citizens, Government of Karnataka is giving the grants to NGOs and getting the scheme implemented through them.

#### 3. Background Information:

There is a need to emphasize free Education to all Differently-abled children between the age Group of 6-18 years as per the Public Primary Education scheme, National Education Policy and People With Disabilities Act-1995.

As per 2011 census, there are 13, 24, 205 persons with disability in the State of Karnataka. Of these, 3.89 Lakhs comprise children are in the age group of 0-19 years. As there is no accessibility to attend normal school for the children with severe disability, special schools are being run by Government and NGO's. There are 300 such special schools in the State of Karnataka. Out of these, 148 schools get grant in aid from the State under two different schemes. In these schools daily living skills, orientation and mobility training and sign language training are imparted. Out of these 300 Schools, some are residential and others are day scholar schools.

Some special schools are still run under Grant-in-Aid code 1982. They do not lay emphasis on the quantum of children and quality of education for the children. Also the grant is not based on the number of students. Also the grants were earlier given to cover teachers' salaries only. To cover more children with disabilities in its realistic terms, the child centric scheme was introduced during 2010-11 with following advantageous objectives.

- 1. Effective implementation of PWD Act 1995 with stress on accessibility to educational facilities.
- 2. To provide disabled friendly environment.
- 3. In accordance with provisions of the constitution, measures to be taken to ensure protection of the right to education of children with disability.
- 4. To achieve 100% literacy among special children.
- 5. To prepare the special children to become part of main stream of the society.
- 6. To encourage the NGO's working in the field of special education.
- 7. To establish skill oriented training center to leprosy cured, mentally ill & eligible mentally retarded children and help them in their rehabilitation.
- 8. To establish residential/day care schools for eligible learning children with mental retardation at district level.

Child centric special schools for differently abled children are run through NGO's getting grants from government of Karnataka on the basis of total number of children present. At present, for each pupil Rs. 2,500 (for hostellers) and Rs. 2,000 (for day scholars) per month is being paid to the institution which is expected to cover all expenditure like honoraria to staff and maintenance etc. But, the institution shall appoint teachers strictly as per teacher student ratio, and also teachers with special education to teach these special children. The teacher student ratio for different types of special children is as below-

- 1. Visual Impaired = 12:1
- 2. Hearing Impaired = 10:1
- 3. Mentally Retarded = 7:1

Since inception of the scheme, 97 special schools have been receiving grant-in-aid from government of Karnataka. These are to be evaluated (list enclosed as **Annexure 1**).

Under the DDRS scheme of government of India, 94 special schools of the State were in getting grants. The NGOs were finding hardship in running special schools. Keeping this in view, and the financial burden faced by the NGOs, the government of Karnataka has introduced Child Centric scheme. As per government order dated 28.08.2013, 68 special schools out of 94 schools under DDR's have been converted to Child Centric scheme. During 2013-14, 97 Special schools have availed this benefit, and 7250 special children are covered.

#### . Evaluation Scope, purpose and objectives:

The scheme is implemented in 30 districts of the state. 300 special schools for various categories of children are run by government and non-government organizations. Of these, 97 special schools are funded by the government of Karnataka under Child Centric scheme. The expenditure of the scheme in last 3 years is as follows:

The Scheme is being implemented since last 3 years, vide State government order no. WCD/109/PHP/2010 dated 14.12.2010. NGO's are eligible to apply for financial assistance only after running the institute with prior permission from the department of empowerment of differently-abled and Senior Citizens for 3 years. Every year the NGO has to apply for grants in a prescribed application with required documents.

In the budget speech dated 14-02-2014, the Honorable Chief Minister of Karnataka has announced to enhance the grants given to NGO's from Rs.2500 per hosteller child per month to Rs.5000 per month, and from Rs.2000 per day scholar child per month to Rs.4000 respectively. Hence, the State Government intends to evaluate effectiveness of the scheme and bring in further reforms, so that, all differently abled children can get the best education and objectives of the scheme are fulfilled.

There is no record of any evaluation of any special schools for differently abled children having been done in the past.

#### 5. Evaluation Questions:

The following are the evaluation questions that the evaluation study is expected to answer. The questions are only inclusive, not exhaustive. They are loosely classified into sub headings as follows-

#### A. Establishment Details:

- 1. Is the NGO registered as a charitable trust, Society or Association under any Act or rules in force in the Union of India and also under Section 50 & 51 of the people with disabilities Act 1955 of disable and Senior Citizens?
- 2. Has the NGO obtained permission from the Department to run the special school? If so, details of such permission be furnished?
- 3. Whether NGO is receiving grants from Center/State or other department of the state or any other local institution foreign funds? What fees expenses, donation charges etc are being collected from the parents or guardians of the students by the Special school?
- 4. Does the institution maintain a statement of Accounts/Registers/Cashbook /relevant Registers, pertaining to grants from the Govt. and is there separate account for the matching grant.
- 5. Is the NGO maintaining and ensuring that while admitting children, no discrimination is being made on the basis of religion caste or creed?
- 6. Is the institution maintaining up to date records as prescribed in page no 7 of the scheme guidelines?
- 7. What is the enrolment, retention and completion figures of Child Centric Schools?
- 8. What is the average expenditure the School claims to incur on each child? Is that all is met through government aid? It not, from where does the difference amount come from?
- 9. In the past three years, how many times has the institution been inspected by the Director of Disabled Welfare? What are the dates of inspection? Are any directions given in the inspection? What are they?
- 10. In the past three years, how many times and on what dates has the District level Committee in charge of the scheme met? What have been the main resolutions/decisions taken there in?

#### B. Infrastructure:

- 1. Does the institution have own /rented building for school and hostel of children?
- 2. What is the extent of area provided in (a) School, and (b) hostel?
- 3. Do they have separate room for each class? (Separate for class I,II, III etc)
- 4. Do they have suitable (in accordance with the physical special needs) scating arrangements in the class room?
- 5. Do they have a staff room?
- 6. Do they have computer facility for staff and students?

#### C. Staff details:

- 1. Are qualified teachers appointed on permanent basis or on temporary honoraria basis? If on honorary basis, whether honorarium is paid through cheque or cash system? What is the honorarium/salary being paid?
- 2. Is Roster system followed at the time of appointing teaching and non teaching staff?
- 3. Whether, all special teachers at primary level are qualified with PUC and Diploma in special education; and at high school level, Graduates with special B.Ed? The deviations may please be listed?
- 4. Are the specially trained teachers registered with Rehabilitation council of India (RCI)? It yes, their names and registration numbers may be documented?
- 5. What is the student teacher ratio of the school in case of hearing impaired, visually impaired and mentally retarded students? How does it compare with the prescribed ratios?
- 6. For all Schools having more than 75 children with speech and hearing impairment there should be a speech Therapist? Does this institution fall under this category? If so do they have speech therapist?
- 7. All Schools having more than 50 mentally retarded children should have a Physiotherapist? Does this institution fall under this category? If so, do they have physiotherapist?
- 8. All Schools for visually impaired children should have a mobility instructor and music teacher. Does this institution fall under this category? Does the institution have such instructors? If so, details of such instructors with their qualifications be mentioned.
- 9. Special primary schools should have a pre-primary school for children in the age group of 4-6 years, with minimum 7 children admitted and specially trained teachers with special D.Ed qualification should be appointed. Does this institution fall under this category? If so does institution have such required trained teachers as per the above standard? Please document details of such teachers?

#### D. Academic details:

- 1. What is the medium of instruction followed?
- 2. Are they following the syllabus prescribed by the State Government Education Department for hearing impaired & visually impaired? Are they maintaining

- the syllabus for mentally retarded & cerebral palsy children, prescribed by the RCI/NIMH to be followed?
- 3. Are student's admissions, attendance and all particulars of the students, along with photograph, age, caste proof, medical certificate/ID card documents are maintained properly?
- 4. Do they have well established library?
- 5. Is monthly test and quarterly examination being conducted? Is progress report of each child maintained and communicated to parents?
- 6. Percentage of pass outs in SSLC in at lease the past 3 years of the schools may be documented?
- 7. Do the teachers prepare and maintain weekly lesson plans and follow them?
- 8. Does the school possess sufficient teaching aids? Do teachers prepare teaching aids using locally available resources? If so, some good ones may be documented/photographed and put in the report?

#### F. Facilities Provided by the Schools:

- 1. Do they have separate dormitory facility for boys and girls?
- 2. Do they have cot, mattress, bed sheets, blankets and pillow with pillow covers?
- 3. Do they have cupboard facilities for children to keep their personal belongings?
- 4. Do they separate study rooms?
- 5. Does the institution provide day to day itinerary for children?
- 6. Do they have recreation facilities? If so, specify?
- 7. Do they provide safe drinking water?
- 8. What is the food menu followed?
- 9. Does the institution have sufficient water facility for bathing, washing and for toilet? Details of such facilities provided be narrated?
- 10.Does the institution provide washing machine for the resident children, and have enough space for drying clothes?
- 11.Do they conduct routine health check up for children? What is its frequency? What was it last held?
- 12.Do they maintain individual case files for residing children? Do they keep track on health, education progress & any other important aspect, of the child?
- 13.Do the institutions have play area in the school for both indoor and outdoor games?
- 14. How often are students taken on excursion? Where have the excursion gone in the past three years?
- 15. Does the Institution make provision for conveyance for children? If yes, what is it?

16. Has the institution provided residential facility for their staff? If so, details of such facility provided?

#### G. Specific outputs:

- 1. What is the perception regarding these schools of the parents of the students?
- 2. What is the integration level of children completing their studies in Child Centric Schools?
- 3. What are the differences between the aid/funding of Child Centric Scheme and Grants-in-aid code 1982 scheme?
- 4. Between the Child Centric Scheme Schools and Grants-is-aid code 1982 scheme schools, are there any significant differences? It yes, what are they? Based upon these, can we say if the former is better or the latter?
- 5. What changes are desirable in the Child Centric Scheme funding system and the schools being run under it?

#### 6. Evaluation Methodology:

Most of the questions of evaluation are to be answered using personal interview technique with written/recorded questionnaire to be answered by the parents of children, except in case of those children, who can answer themselves (for example visually impaired children).

Measurement of integration in point number 2 of "specific outputs" above means tracking school pass outs of one or two years prior to evaluation year, and finding how many of them are studying along with normal students or in vacations the same as of normal students/persons.

All records and events being part of evaluation questions need to inspected by the evaluating agency, and, if need be, a copy kept as record? It is expected that the best practices or best facilities the agency comes across will be documented and presented in the evaluation report.

It is expected that the evaluation report will give the correct amount of expenditure required to incur per month on a differently abled child student per month. Variations on the type of disability and districts may also be given.

#### 7. Sampling Methodology:

1. There are 97 Child Centric Special Schools in the State. The names addresses and type of school is enclosed as **Annexure-1**. Amongst these, in

consultation of the line department and KEA, a sample of institutions h been selected. These are the ones where the "italics" fonts are used. The sample has been selected by stratifying the population across districts and selecting at least one institution from each district as the sample or 25% intensity, whichever is more. The sampled schools will be visited by the evaluating agency in course of its evaluation and in case of the other 73, the questionnaire will be sent to the heads of the schools who would get the responses filled in and send to the evaluating agency. In case the responses received therein are very different from the sampled schools, the evaluating agency should visit the concerned school/schools to validate the response

2. There are 36 schools being run under Grants-in-aid code 1982 scheme. A sample of that of 25% intensity (excluding vocational training schools as they are not in Annexure-1 at all) is selected with sample names occurring in italics. These are to be evaluated for comparison as to whether there is significant difference between Child Centric Special Schools and these.

# 8. Deliverables and time schedule:

The department for the Empowerment of Differently Abled and Senior Citizens will provide the required information and data to the prospective applicants. Successful Consultant is expected to adhere to the following timelines

1. Work plan submission : One month after signing the agreement. 2. Field Data Collection

: One month from date of work plan

approval.

3. Draft report Submission: One month after field data collection.

4. Final Report Submission: One month from approval of draft report.

: 4 months.

Thus excluding the time taken for approval, the evaluation study should be completed in 4 months time.

# 9. Cost and schedule of budget releases:

Output based budget release will be as follows-

a. The first installment of Consultation fee amounting to 30% of the total fee shall be payable as advance to the Consultant after the approval of the inception

- report, but only on execution of a bank guarantee of a scheduled nationalized bank valid for a period of at least 12 months from the date of issuance of advance.
  - b. The **second installment** of Consultation fee amounting to 50% of the total fee shall be payable to the Consultant after the approval of the Draft report.
  - c. The **third and final installment** of Consultation fee amounting to 20% of the total fee shall be payable to the Consultant after the receipt of the hard and soft copies of the final report in such format and number as prescribed in the agreement, along with all original documents containing primary and secondary data, processed data outputs, study report and soft copies of all literature used to the final report.

Taxes will be deducted from each payment as per rates in force. In addition, the evaluating agency/consultant is expected to pay services tax at their end.

#### 10. Qualifications of the consultants and method of selection:

Consultants should have and provide details of evaluation team members having qualifications/capabilities as below-

- i. One Social Scientist/Statistician knowing design of experiments,
- ii. At least one post graduate in social work/sociology having experience in conducting studies related to differently abled children,
- iii. One Educationist (preferably dealing with special children), and,
- iv. One Psychologist (desirable).

And in such numbers that the evaluation is completed within the scheduled time prescribed by the ToR.

#### 11. Ensuring quality:

The evaluation report and its findings must demonstrate highest professional standards on par with national and international studies.

#### 12.Qualities Expected from the Evaluation Report

The evaluation report and its findings must demonstrate highest professional standards on par with national and international studies.

The following are the points, only inclusive and not exhaustive, who need to be mandatorily followed in the preparation of evaluation report:-

- 1. By the very look of the evaluation report it should be evident that the study is that of Karnataka Evaluation Authority of Government of Karnataka which has been done by the Consultant. It should not intend to convey that the study was the initiative and work of the Consultant, merely financed by the Karnataka Evaluation Authority and Government of Karnataka.
- 2. The Terms of Reference (ToR) of the study should from the first Appendix or Addenda of the report.
- 3. The results should first correspond to the ToR. In the results chapter, each question of the ToR should be answered, and if possible, put up in a match the pair's kind of table, or equivalent. It is only after all questions framed in the ToR that is answered, that results over and above these be detailed.
- 4. In the matter of recommendations, the number of recommendations is no measure of the quality of evaluation. Evaluation has to be done with a purpose to be practicable to implement the recommendations. The practicable recommendations should not be lost in the population maze of general recommendations. It is desirable to make recommendations in the report as follows:-

## (A) Short Term practicable recommendations

These may not be more than five in number. These should be such that it can be acted upon without major policy changes.

## (B) Recommendations requiring change in/of policy

These are those which will need lot of time, resources and procedure to implement or those which intend to drastically modify the scheme.
