Sub: Re-Constitution of Technical Committee of Karnataka Evaluation Authority(KEA).

PREAMBLE:-

Karnataka Evaluation Authority (KEA) was constituted vide Government Orders cited under read(1) to carry out transparent, effective and efficient practice of evaluation of development policies and programmes of Government. To take up all technical matters related to an evaluation including ToR preparation, evaluation methodology, Sampling techniques, Preparation of Manual etc. the Technical Committee is constituted under Annexure-II of the Government Order cited under read(1) with the following members;

As a part of the continuous improvement exercise in KEA for achieving better outcomes, General Body of KEA in its 5th meeting held on 12.10.2018 under chair of Chief Secretary, GOK discussed the proposal for change in composition of Technical Committee. After discussions, it was decided as follows;

- (i) to include Director, National Institute of Advanced Studies(NIAS), Bengaluru and Deputy Director General, NSSO Regional Office, Bengaluru as members in place of Director, Fiscal Policy Institute
- (ii) Replace Director, Indian Institute of Management(IIMB) with Head Public Policy Division, Indian Institute of Management, Bengaluru (IIMB)
- (iii) To co-opt additional members with a member from Bangalore University and replace the two members whose term is completed.

The General Body approved for re-constitution of Technical Committee under the power vetted by rule 14(7) & (8) of Rules of the Karnataka Evaluation Authority(Annexure-II of Government Order No. PD/8/EVN(2)/2011, Bangalore dated 11.7.2011). The Governing Body in its 17th meeting noted the changes made in the composition of Technical Committee of KEA and approved the list of members incorporated in the Committee. Hence the following order.
