## Preamble:

- 1. In the Government Order PD 8 EVN (2) 2011, Bangalore, dated 11.07.2011 the establishment of the Karnataka Evaluation Authority (KEA) was approved with a sanctioned strength of 19 posts to provide for a focal point for evaluation of Government programmes and schemes.
- 2. In the Government Order PD 20 EVN 2011, Bangalore, dated 05.09.2011 the State Government approved the by-laws of KEA and accordingly Karnataka Evaluation Authority was registered as a society under the Karnataka Societies Registration Act 1960 on 19.09.2011. In the Government Order PD 14 EVN 2012 dated 25.05.2012, two out of the 4 posts of Research Assistants were upgraded to the posts of Evaluation Officers, and two posts were redesignated as Procurement Officer and Project Formulation and Monitoring Specialist respectively.
- 3. Article 5(7) of the Memorandum of Association of KEA provides for creation of posts. It reads as follows:

"Create administrative, technical, ministerial and other posts in the society and make appointment thereto in accordance with the Rules and Regulations of the society."

4. The General Body of Karnataka Evaluation Authority chaired by the Chief Secretary to Government in its 2nd meeting held on 01.10.2012 considered the subject regarding creation of additional posts and constituted a subcommittee under the chairpersonship of Principal Secretary, Planning, Programming Monitoring and Statistics Department to examine the staffing needs of KEA. The Sub-Committee considered the issue and submitted its report. The Government vide its order No.PD 90 KEA 2012 Bangalore dated 16.04.2013 enhanced the total posts to 40 with 5 Director Evaluations, 10 Associate Directors, 2 Office Assistants amongst others.

- 5. For effective functioning of KEA, the 16th Governing Body in its meeting held on 16th July, 2018 reviewed the existing structure of KEA and resolved to constitute four divisions viz.,(i) Evaluation Division, (ii) Procurement and Coordination Division (iii) Publication and Extension Division and (iv) Statistical Analysis and Information Technology Division. The proposal was approved by the General Body in its 5th meeting held on 12th October 2018 of KEA Chaired by the Chief Secretary to Government of Karnataka subject to concurrence of the finance department. A proposal for change in cadre of certain posts, redesignating was submitted to the Finance department through the president of the governing body by way of a U.O.Note and the file. Finance Department vide its file No. 242 34 6/2019 dated 12.06.2019 has approved the same.
- 6. Further the pay scale of 5th pay commission was adopted vide Government order dated 16.04.2013. These scales have been revised by the 6th pay commission which has been approved by the Government vide order No. FD 06 SRP 2018 dated 19.04.2018. The revised pay scales need to be adopted to enable deputed officers / staff to draw their pay and allowances.
- 7. A proposal for change in cadre of certain posts, redesignating a few was built by KEA and submitted to the Finance department through the president of the governing body as below.
